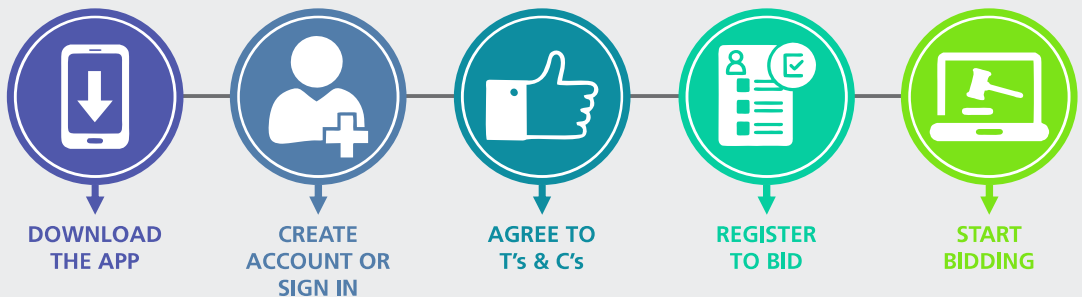

APP Registration Process

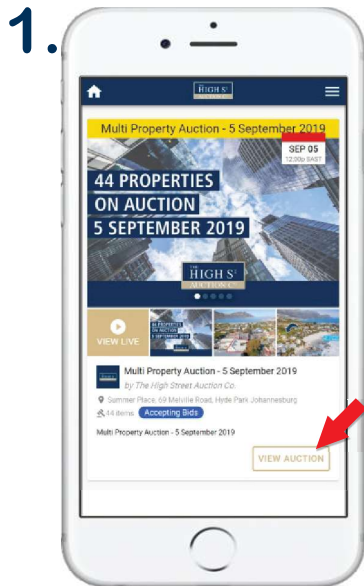
