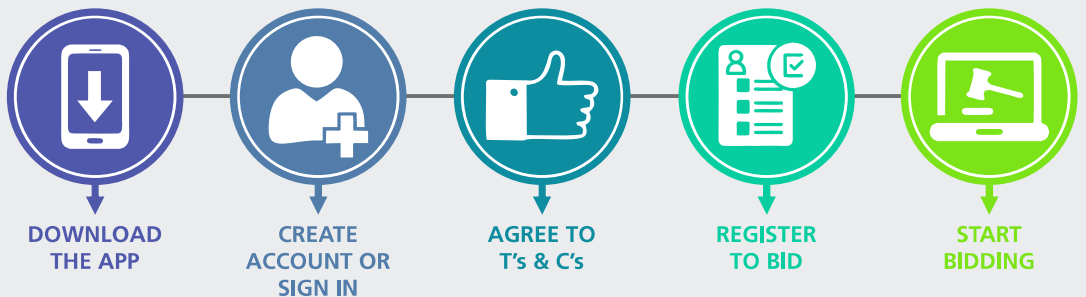

APP Registration Process

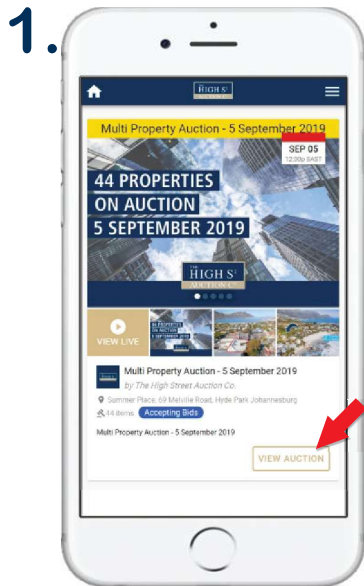

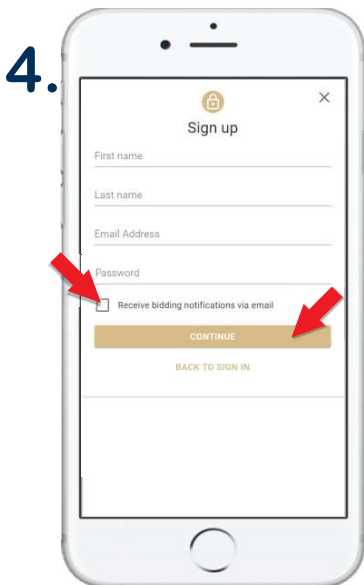
1. Once you have downloaded the app, open it and click on **“VIEW AUCTION”** to view our current auction properties/movables.



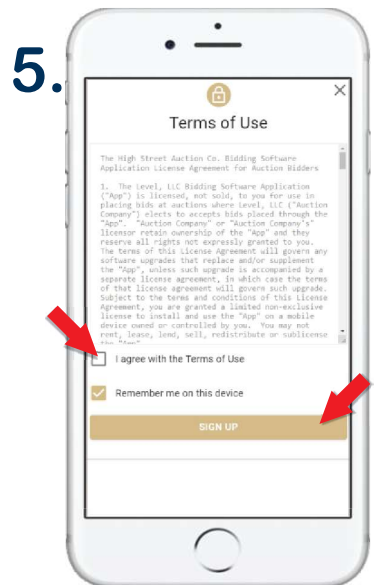
